MESSAGE FROM OUR CHAIR WAYNE PLUMMER

Tēnā koutou

It is hard to believe that 2022 could have been as challenging as 2021 – let alone more.

Over the past 12 months, Aotearoa New Zealand has felt the full force of the Covid-19 pandemic. In August 2021 the Delta strain of Covid-19 finally penetrated our strict border controls sending the country into another full lockdown, with the Auckland region predominantly working from home until December when the "traffic light system" came into effect.

With the first case of the Omicron variant detected in the community in January 2022, we were again plunged into lockdown under the new red traffic light setting. A big thanks to you all for your amazing efforts and commitment in 2021/22.

Reflecting on the past year, I think the standout and most rewarding aspect of the year for me was our people - not just from the WasteMINZ team, but from across the entire sector including you; our members. Under sometimes extremely challenging and dynamic situations, we all put in the mahi during a time of need and worked together for a common cause as an essential service. Central government departments, local government teams, consultants, waste and recycling contractors, small businesses, and notfor-profit organisations worked tirelessly with our wonderful WasteMINZ team to support the community. This highlighted to me that we can work collectively and cohesively as a sector, and that we can achieve great outcomes by channelling our energy to common goals.

The sector groups continue to be the foundation of WasteMINZ. The work

of these groups over the past 30 plus years are what has driven some of the most transformative changes within government waste strategy and policy this generation. MESSAGE FROM OUR CHIEF EXECUTIVE NIC QUILTY

Ngā mihi nui ki a koutou katoa

With the support and guidance of the WasteMINZ Board and hard work of the team, we have come out of a challenging year reasonably unscathed. WasteMINZ budgeted for a deficit in 2022 of \$51,681 and came out with a surplus of \$74,061 (compared with a deficit of \$102,366 in 2021).

We had a change in leadership in February 2022, with Janine Brinsdon passing the banner to me. Janine navigated the team through the rough waters of Covid-19, as she had done the year before, and she did this admirably, in very challenging circumstances, not the least of which was not being able to run any in-person events due to Covid-19 restrictions.

Covid-19 scuppered our attempts to run an in-person conference, due to lockdowns or the threat of lockdowns, but we rose to the challenge and transitioned to a virtual summit, which ran in late May 2022. We were delighted when 505 people attended, but we know that inperson events are your preference. Ask and you shall receive. The WasteMINZ Collaborative Workshop will run on 24 November 2022 and the WasteMINZ conference from 22 to 25 May 2023.

Our sector groups continue to thrive, and they pedalled madly to keep up with central government's release of various consultations, which included the resource management system reform, a proposed new national waste strategy, the Waste Minimisation Act review, the emissions reduction plan, and Transforming Recycling. Submissions were made on all of these by the relevant sector groups.

The sector groups have worked on some exciting projects, campaigns and events and I will mention some of them here. You can read more about the sector groups on pages 8 to 16. The Health & Safety Sector Group ran a road safety campaign in May 2022 to raise awareness of the need to keep safe around recycling and rubbish trucks. The Contaminated Land Management Sector Group have agreement from Kainga Ora and Soilsafe Aotearoa to share their data on residential soil lead concentrations in New Zealand. This group is also nearing completion of the module on disposal of low-level asbestos-contaminated soil at a landfill, which will be incorporated into WasteMINZ's existing asbestos disposal guidelines later this year. The Disposal to Land Working Group are in the final stages of completing the updates to the Technical Guidelines for Disposal to Land (which will incorporate the waste acceptance criteria for Class 3). This group is also working with the Ministry for the Environment to update the National Waste Data Framework.

The Organic Materials Sector Group, in collaboration with The Packaging Forum, hosted two hui for composters regarding PFAS in fibre-compostable packaging. The Product Stewardship Sector Group facilitated webinars on behalf of the co-design leads for e-waste and farm plastics, so that stakeholders have an opportunity to provide input into the co-design process of proposed regulated product stewardship schemes. The Recycling & Resource Recovery Sector Group have begun work on a material flows analysis for different waste items so that opportunities for recovering materials can be identified. The Territorial Authorities' Officers Forum concluded their three-year Rethinking Rubbish and Recycling Campaign with a Rinse, Recycle Repeat campaign. So much work has been done by the sector groups over the past year and they are to be congratulated.

There are also lots of other people that need to be thanked; the team - CJ, Elaine, Gel, Leeana, Sarah, Sharmaine, and Tess for their dedication and hard work over the year. They pull out all the stops and make things happen. Without them I would be lost. I would also like to thank the Board; Alec, Alice, David, Parul, Todd, and Wayne. Their guidance and support has allowed me to grab opportunities and make necessary changes. To those who volunteer their time on our steering committees and working groups: your passion and dedication astounds me thank you. And, finally, to our members: thank you for supporting WasteMINZ without you we wouldn't exist.

This sector group supports WasteMINZ's major behaviour change project Love Food Hate Waste. A new committee was elected in September 2021 after a hiatus from this sector group over the previous year.

LOVE FOOD HATE WASTE

The key Love Food Hate Waste theme for September 2021 was Value Your Food. The aim of this campaign was to remind people of all the resources and mahi that go into producing our kai, as well as the carbon emissions that are produced as food travels from the paddock to our plates. LFHW collaborated with Beef and Lamb NZ to produce a video demonstrating the value of your food kaupapa, and tiles were also produced to demonstrate how much water, sunshine and work goes into producing different items of food. LFHW NZ also took part in the UK initiated Food Action week in March which also demonstrates the link between wasting food and climate change. Throughout the rest of the year different themes were explored through our social media platforms, and media interviews were given on the topic of food waste. In addition, four seasonal meal planners were produced in collaboration with New World to help households make family-friendly, budget-conscious, nutritious meals that don't produce food waste.

EVENTS

The committee worked with the Contaminated Land Management Sector Group to hold two online workshops on Te Tiriti o Waitangi in February. These workshops were well attended with approximately 77 members attending.

Behaviour change topics were explored in a session entitled "Effective engagement" at WasteMINZ virtual summit in May.

RESOURCE MANAGEMENT (RM) REFORM REFERENCE GROUP

In May 2021, the Contaminated Land Management Sector Group Steering Committee issued a formal letter to the Ministry for the Environment (MfE), offering to form a 'Contaminated Land Reference Group' to provide support to MfE's contaminated land team. MfE accepted the offer in June 2021. The Terms of Reference for the Resource Management Reform (Contaminated Land) Reference Group were finalised in September 2021. The reference group met in October 2021, March and April 2022 and provided feedback to four separate requests from MfE.

ENGAGEMENT WITH MINISTRY

The steering committee continues to engage with MfE, attending the steering committee's meetings throughout the year to discuss MfE's workplan and areas of collaboration.

CONTAMINATED SITE SAFETY CERTIFICATE COURSE

The Contaminated Site Safety Certificate course was developed in 2019 and Vertical Horizonz NZ was appointed as the training provider. Courses were held in Wellington and Christchurch in July 2021, Hamilton in May 2022, and Christchurch in June 2022.

RESIDENTIAL LEAD

The group continues to build relationships with key stakeholders including Kāinga Ora, the Ministry of Health, Massey University and Soilsafe Aotearoa. The group finalised their reviews of the scientific research on human health risks of lead in the UK, Australia and the US in late 2021 and turned their attention to gathering data on residential soil lead concentrations in New Zealand. The group has obtained agreement from Kāinga Ora and Soilsafe Aotearoa to share the data that these organisations hold and have identified other organisations that may hold data.

ASBESTOS DISPOSAL WORKING GROUP

The group finalised the first draft of the module 'Disposal of low level asbestos-contaminated soil at a landfill' which will be incorporated into the existing asbestos disposal guidelines in December 2022. They met with WorkSafe to discuss WorkSafe's review of the module in January 2022. During that meeting WorkSafe noted that there are inconsistencies in the classifications of asbestos works in the New Zealand Guidelines for Assessing and Managing Asbestos in Soil (NZGAMAS) and the Health & Safety at Work (Asbestos) Regulations 2016. The working group agreed that revisions to the module were needed to address these issues and bridge the gap between the NZGAMAS and are working on finalising a second draft of the module.

COAL TAR IN ROADING WORKING GROUP

The group was formed in October 2021 to develop guidance on historical coal tar contamination in roading materials for both industry and councils. The group has met monthly and have agreed the scope of the guidance document and several key definitions. The group is currently reviewing and finalising the draft document which will be consulted on with key stakeholders in late 2022.

SOIL DISPOSAL SAMPLING & RE-USE GUIDANCE WORKING GROUP

The group was formed in early 2022 to develop guidance on sampling methodology for determining disposal of excess soils. This is a joint working group with the Disposal to Land Sector Group, with members from both sector groups and steering committees on the working group. The group has performed a technical gap analysis which outlines a larger work programme. The overarching goal is contributing to a nationally consistent methodology for soil disposal to land that identifies commercial, environmental and health risks associated with excess soils so that those risks can be managed and valued with the minimum impact.

The monthly CLM digest was delivered electronically to 460+ members.

TECHNICAL GUIDELINES FOR DISPOSAL TO LAND

In the first half of 2020, the Ministry for the Environment (MfE) appointed a reference group to review the waste acceptance criteria (WAC) for organic and inorganic contaminants in Class 3 and Class 4 fills. The report setting out the new WAC for Class 3 fills and revised WAC for Class 4 fills was released in June 2021. In early 2022 WasteMINZ staff, representatives of the reference group, and MfE met to determine how to incorporate the revised WAC into the guidelines. A draft which includes the revised WAC and changes necessitated by the update was completed in June 2022 and editing of the final document is underway.

WASTE DISPOSAL LEVY

The steering committee met with MfE in July 2020 to discuss their concerns with the changes to the levy and how the steering committee could assist MfE with the implementation process. The committee identified several areas it could work with the Ministry on, and terms of reference were agreed to. The steering committee met with MfE to discuss implementation of the levy in August and October 2021, and February and June 2022. The steering committee provided feedback on MfE's Inaugural Compliance, Monitoring and Enforcement report and the Alleged Breach Notification portal.

NATIONAL WASTE DATA FRAMEWORK UPDATE

MfE approached WasteMINZ in September 2021 with a proposal to update the National Waste Data Framework to include sites with mandatory data reporting requirements under the waste disposal levy expansion and additional waste data reporting proposed by the waste data Cabinet paper. WasteMINZ and MfE met in late 2021 and early 2022 and agreed that as MfE had requested the update and was funding the work, MfE would run the procurement and oversee the work. WasteMINZ as the owner of the framework would review and approve all final products and assist with consultation on the deliverables. In addition, WasteMINZ would form a technical advisory group (TAG) to provide input and feedback to the project team. The TAG was formed in June 2022. The anticipated timeframe for the project is July-November 2022.

HEALTH & SAFETY GUIDELINES

The committee agreed that there would be a rolling review of the 'Health and Safety Guidelines: for the Solid Waste and Resource Recovery Sector – parts one, two, three, four and five'. Part 1 (Introduction, legislation, and regulations) and Part 2 (generic modules and waste collection modules) were completed in 2021. The working group made updates to Part 3 (pandemic management, material recovery facilities, and resource recovery parks) in 2022 and this part will go to the steering committee for peer-review, then to the sector group for consultation later in 2022.

KERBSIDE COLLECTION TRAFFIC LEADER (KCTL)

WasteMINZ facilitated four workshops and more workshops are set for November 2022. KCTL training material will need to have a review with the course material to be updated by the working group.

CODE OF PRACTICE FOR TEMPORARY TRAFFIC MANAGEMENT (COPTTM)

The CoPTTM has undergone a significant review and will be replaced with the New Zealand guide to temporary traffic management. Waka Kotahi released the guide 31 August 2022.

ROAD SAFETY CAMPAIGN - DO BIN DAY THE SAFE WAY

This campaign was designed to raise public awareness around waste and recycling collection services, and the risks of large vehicles working amongst cyclists, pedestrians and other road users. The campaign launched in May 2022 with a very successful 4-week radio campaign, and media attention on TV3's AM show, along with WasteMINZ social media channels.

LEAD THE WAY, BETTER WORK CAMPAIGN

This new campaign raises awareness of working better within the industry. Every month WasteMINZ shares the committee's top tips on key safety issues.

WASTESAFE TRAINING

Developing industry specific training is a priority for the steering committee.

NEW COMMITTEE

A new committee was elected in September 2021 and the strategic vision and work plan finalised in February 2022. The main focus is changing the emphasis on diverting organic material from landfill to producing a high value product that is recognised by primary producers as being a way of contributing to soil health and reducing reliance on synthetic fertilisers.

COMMUNICATION

The committee produced a video articulating their vision for organic materials in Aotearoa New Zealand for the Australian Organic Recycling Association conference in June.

KNOWLEDGE

The sector group has become part of an international coalition of composting industry groups with the aim of learning about what is happening in the sector internationally and applying overseas research in the context of Aotearoa. New Zealand

EVENTS

In February 2022, in collaboration with The Packaging Forum, the sector group hosted two hui for composters regarding PFAS in fibre compostable packaging.

The organic materials session at the WasteMINZ virtual summit in May 2022 explored this topic with a keynote from Alison McKinnie from Zero Waste Scotland on their 10-year journey on developing market confidence. This was followed up with a panel discussion on creating new markets for organic materials.

ADVOCACY

The steering committee continued its commitment to ensuring stakeholders have opportunities to provide input into the co-design process of proposed regulated product stewardship schemes by facilitating webinars on behalf of the co-design leads for e-waste and farm plastics. They also facilitated and participated in webinars on linking waste back to primary production, right to repair and the launch of the Textile Product Stewardship Scheme pilot.

Committee members also wrote articles on product stewardship for revolve and other publications.

As part of their goal of communicating the benefits of product stewardship to the wider public a working group established under the committee produced two short videos.

RETHINKING RUBBISH AND RECYCLING

The 3-year Rethinking Rubbish and Recycling Campaign, co-funded by MfE's WMF fund and the TAO Forum's collaborative fund, concluded with a very successful content driven campaign Rinse, Recycle, Repeat. Motuihe Group was the successful creative agency to pitch for this campaign and the result was an estimated 1.8 million audience, 16 interviews with print, radio and TV media, 38,373 likes, comments and shares on social media. 243 entries were received and the winner was a Gisborne area school, Wainui Beach, who won \$25,000 for their efforts.

COLLABORATIVE FUNDING

With the completion of the Rethinking Rubbish and Recycling Campaign, which was partially funded by the TAO Forum Collaborative Fund, the process for securing the next amount of collaborative funding began with 42 out of 66 member TAs committing to contributing to it.

SURVEYS

A survey on the costs of collecting e-waste was developed and sent out to TAs for themselves or their contractors to complete. The purpose of this survey was to contribute to the development of the product stewardship scheme for e-waste so that the costs of collecting e-waste (not just recycling it) are covered. This was to fill a gap in the work done to date by the lead on the co-design of the e-waste scheme, TechCollect NZ, and their independent chair, EY.

A survey was conducted on hazardous waste collections by TAs or their contractors on behalf of AgRecovery. Reports based on surveys carried out with the TAO Forum were produced on illegal dumping, and waste and recycling data.

EVENTS

The TAO Forum ran the day before the WasteMINZ virtual summit, which included presentations on MfE work related to TAs, and a workshop on social change theory.

The Forum regularly participated in the Waste Minimisation Officer's Zui.

WORKING GROUPS

A working group on illegal dumping of rubbish was established for a short period of time.

A working group on minimising waste on multi-unit dwellings was established after being initiated by a TAO Forum member.

OUR EVENTS

WASTEMINZ SUMMIT

Due to Covid-19 restrictions, the decision was made in February 2022 to transition our in-person conference to a virtual summit. The event ran from 9 to 11 May 2022 and was very well-supported, with just over 500 delegates. The summit included a contaminated land management workshop, which focused on Te Ao Māori and Mātauranga Māori, and a Territorial Authorities' Officers Forum on day one. Keynote sessions, panel discussions and presentations followed on days two and three.

WasteMINZ's first in-person conference since 2019 will be held at Claudelands in Hamilton and will run from 22 to 25 May 2023.

We were unable to run any in-person networking events, due to Covid-19 restrictions.

NOTES TO THE FINANCIAL STATEMENTS

STATEMENT OF ACCOUNTING POLICIES

1 REPORTING ENTITY

The financial statements presented here are for the entity Waste Management Institute New Zealand Incorporated. Waste Management Institute New Zealand Incorporated is incorporated as a board under the Incorporated Societies Act. The Financial Statements of Waste Management Institute New Zealand Incorporated are special purpose financial statements which have been prepared in accordance with the special purpose financial reporting framework for use by For-Profit Entities (SPE-FPE) published by NZ Accounting Standards Board, based on the requirements of external users of the financial statements and its members.

2 MEASUREMENT BASE

The accounting principles recognised as appropriate for the measurement and reporting of earnings and financial position on an historical cost basis have been used, with the exception of certain items for which specific accounting policies have been identified.

3 CHANGES IN ACCOUNTING POLICIES

There have been no changes in accounting policies. All policies have been applied on bases consistent with those used in previous years.

4 SPECIFIC ACCOUNTING POLICIES

The following specific accounting policies which materially affect the measurement of financial performance and the financial position, have been applied:

(a) Differential Reporting

Waste Management Institute New Zealand Incorporated is a qualifying entity in that it qualifies for Differential Reporting as it is not publicly accountable and there is no separation between the owners and the governing body.

All Differential Reporting exemptions have been applied.

(b) Fixed Assets & Depreciation

The entity has the following classes of fixed assets:

Office Equipment

Motor Vehicle

Land and Building

All fixed assets are initially recorded at cost with depreciation being deducted on all tangible fixed assets other than freehold land, in accordance with rates set out in the Income Tax Act 2007.

(c) Goods & Services Tax

The Statement of Financial Performance and Statement of Cashflows (where included) have been prepared so that all components are stated exclusive of

GST. All items in the Statement of Financial Position are stated net of GST, with the exception of Accounts Receivables and Payables.

(d) Income Tax

A provision has been made for Fringe Benefit Tax Payable.

A provision has been made for Tax Payable on non member earnings.

Waste Management Institute New Zealand Incorporated is eligible for the income tax deduction as a non-profit body afforded by the IRD.

(e) Receivables

Receivables are stated at their estimated realisable value. Bad Debts are written off in the year in which they are identified.

(f) Investments

Investments are carried at the lower of cost and net realisable value. Where in the opinion of the Board there has been a permanent reduction in the value of the investments, this has been brought to account in the current period.

5 OPERATIVE COMMITMENTS

The society has an operating lease commitment with Fuji Xerox for one year. \$2,942.64 for 2022.
